Bidders must submit certified copies of the Bidder's Registration, VAT Registration and up-to-date Tax Clearance Certificate along with a written request for the bidding documents.
- 4. Bids must be submitted to Social Science Baha on or before 1200 hours NST on 23 January 2024. Documents received after this deadline will not be accepted.
- 5. Bids will be opened in the presence of the Bidders' representatives who choose to attend at 14:00 hours NST on 23 January 2024 at Social Science Baha, Battisputali.
- 6. Bids must be valid for a period of 90 days after the bid opening and must be accompanied by a bid security for the amount as specified in Clause 11 and valid for 30 days beyond the bid validity period.
- 7. A pre-bid meeting will be held on 14 January 2024 at 1200 hours NST at Social Science Baha. The attendance in the pre-bid meeting is optional but interested bidders are encouraged to attend it.
- 8. Bidders are advised to visit the proposed construction site at Gaushala and assess the actual site conditions before submitting their bid.
